Riverview Health Care Foundation has been an integral part of our community for 25 years by supporting excellence in wellness and healthcare. From its inception in 1984 through December 31, 2009, nearly 4.5 million dollars have been granted by the Foundation to Riverview Hospital Association and other local nonprofit agencies in support of wellness and healthcare initiatives.

Through December 31, 2009, Riverview Hospital Association has received 170 grants from the Foundation totaling \$3,548,455. A total of 107 grants adding up to \$880,942 have been made to local non-profit organizations to benefit the community's health. Over the Foundation's 25 year history, total grants awarded in support of excellence in wellness and healthcare amount to \$4,429,397.
